***AN ORDINANCE AUTHORIZING THE SALE OF SURPLUS  
PROPERTY CONSISTING OF ONE 2008 FORD CROWN VICTORIA WITH  
A VEHICLE IDENTIFICATION NUMBER OF 2FAFP71V88X179657***

***WHEREAS***, it is no longer necessary, useful to, or in the best interest of the City of Park City to retain ownership of a 2008 Ford Crown Victoria, with a VIN Number of 2FAFP71V88X179657; and

***WHEREAS***, the City of Park City is a home rule municipality duly organized and operating under the laws of the State of Illinois; and

***WHEREAS***, pursuant to Section 6 of Article 7 of the Constitution of the State of Illinois, the City of Park City has home rule authority to dispose of surplus property no longer needed by the municipality.

***NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PARK CITY, LAKE COUNTY, ILLINOIS IN THE EXERCISE OF ITS HOME RULE POWERS AS FOLLOWS:***

**SECTION I:** The preceding whereas clauses are hereby made a part of this Ordinance.

**SECTION II:** That the Mayor be and is hereby authorized and directed to dispose of, liquidate and sell the 2008 Ford Crown Victoria, with a VIN Number of 2FAFP71V88X179657 to the entity or person who offers the highest price, and deposit the proceeds into the City treasury.

**SECTION III:** Nothing in this Ordinance shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or liability incurred, or any cause or causes of action arising, acquired or existing under any act or ordinance or portion thereof hereby repealed or amended by this ordinance; nor shall any just or legal right, claim, penalty or remedy of any character of the corporate authority existing on the effective date hereof be lost, impaired or affected by this Ordinance.

**SECTION IV:** All ordinances or parts of ordinances in conflict herewith are to the extent of such conflict, hereby repealed.

**SECTION V:** This ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as required by law.
